Roll call was taken by the property manager, Armando Fernandez. All Board members were present except for Gloria Kosiba and Elmer Foster.

Quorum

A quorum was present, and the Board of Directors Meeting was formally recognized at 7:34 P.M.

Motion

Miramar Police was present. Officer Serjur was present in place for Officer Singletary. He gave the community updates for the month of January. He reported that two burglaries occurred in Silver Shores. One in parcel B and the other in parcel G. He emphasized if someone sees that something does not look right, they should call the police. He also reminded everyone to use their alarm system if they have one. Everyone should keep their property secured at all times.

The President asked a resident Olga Morales to stop recording the meeting. She was reminded that the process to videotape a meeting is to submit a written request to the office at least two days prior to the meeting. Ms. Morales had not submitted a request and had her son who is a minor recording the meeting. After the President made the request to stop recording the meeting, Ms. Morales continued to have her son record the meeting without the Board's approval.

The President requested that all directors should take a few minutes to review the board minutes and the management report. He further explained that the November 4th and the 18th meeting minutes were included for ratification. After a few minutes, the motion to accept both the November 4th and 18th minutes as written was made by Rollington Mills and seconded by Gladys Castro; all were in favor.

The President, Morris Hatcher presented a landscape plan that he requested all Board members to carefully review so they can be prepared to discuss it at the March Board of Director's meeting.

Reserve Fund Study
